Perjalanan karir beliau dalam bidang perbankan dan pasar modal telah mencapai tiga dekade. Pengalaman dalam bidang perbankan beliau dimulai di PT Bank Danamon Tbk (1989-1990) dan dilanjutkan di Standard Chartered Bank (1991-1994) dan Deutsche Bank AG Cabang Jakarta (1994-1997). Pengalamannya di pasar modal dimulai di PT Lippo Securities Tbk (1997-1998), kemudian berlanjut menjabat sebagai Presiden Direktur Kustodian Sentral Efek Indonesia (1998-2006). Kepemimpinan beliau berlanjut sebagai Presiden Direktur PT Ciptadana Capital (2006-2011). Beliau pernah menjabat sebagai Presiden Komisaris PT Lippo General Insurance Tbk (2014-2020), serta Komisaris di PT Multipolar Tbk (2014-2020), kemudian sebagai Komisaris di PT Lippo Karawaci Tbk (2016-2018) dan Komisaris PT Lippo Securities Tbk (2015-2020). Sejak tahun 2023, beliau menjabat sebagai Presiden Direktur PT Siloam International Hospitals Tbk berdasarkan keputusan Rapat Umum Pemegang Saham tanggal 25 Mei 2023.

Beliau adalah warga negara Indonesia, berusia 63 tahun per 31 Desember 2023.

Beberapa gelar pendidikan yang beliau raih adalah Master of Business Administration dari Washburn University, Topeka, Kansas, Amerika Serikat (1989) dan Bachelor of Economics dari Brandon University, Manitoba, Kanada (1985).

His career in banking and capital markets spans three decades. His experience in banking began at PT Bank Danamon Tbk (1989-1990) and continued at Standard Chartered Bank (1991-1994) and Deutsche Bank AG Jakarta Branch (1994-1997). His experience in capital markets started at PT Lippo Securities Tbk (1997-1998), then continued appointed as President Director of the Indonesian Central Securities Depository (1998-2006). His leadership continued as President Director of PT Ciptadana Capital (2006-2011). He was appointed as President Commissioner of PT Lippo General Insurance Tbk (2014-2020), as well as Commissioner of PT Multipolar Tbk (2014-2020), then as Commissioner of PT Lippo Karawaci Tbk (2016-2018, and Commissioner of PT Lippo Securities Tbk (2015-2020). Since 2023, he has served as President Director of PT Siloam International Hospitals Tbk based on the resolution of the General Meeting of Shareholders dated May 25, 2023.

As of December 31, 2023, he is a 63-year-old Indonesian citizen.

He holds several educational degrees. He achieved a Master of Business Administration from Washburn University, Topeka, Kansas, United States (1989) and a Bachelor of Economics from Brandon University, Manitoba, Canada (1985).
